In the absence of a County or District Councillor, the Clerk provided an update on the Local Government Review which was announced earlier in the day. Lincolnshire County Council and all seven district councils will be abolished and replaced by two unitary authorities, "City of Lincoln" and "Lincolnshire Council".

A member of the public raised two items:

- Grass cutting along Moortown Road stops before the new housing development. Council agreed to review extending the area that is cut.
- Moortown Road needs more 30mph signs. It was explained that the presence of streetlamps indicates a 30mph zone and the parish council is not permitted to erect additional signage.
